Judge Alvaro T. (Balo) Garza, age 81, passed away July 10, 2022, in San Antonio, TX. He was surrounded by his wife and immediate family as he went to be with his Lord and Savior.

Balo is reunited in heaven with his children, Marleni Erica and Alvaro Rene. He is survived by his beloved wife of 44 years, MariaElena (Nena), granddaughter Marleni Renae', and son Kevin, from a previous marriage. Balo was appointed by President Clinton in 1994 as a Federal Administrative Law Judge in San Antonio, Tx.
