



## Byron B. Riley, Jr.

April 7, 1935 - October 12, 2006

Byron B. Riley, Jr., also known as “Jim”, was born April 7, 1935, in Bridgeport, West Virginia, and died in San Antonio on October 12, 2006. Jim won six Varsity Athletic letters at West Virginia University, and was selected as the first to teach Russian in West Virginia to elementary school students. He then entered the U.S. Air Force and retired as a judge advocate in 1991 after 27 years of service. Lt. Col. Riley next was appointed an administrative law judge in 1992 by the Governor of West Virginia where he worked until 2006, when he retired due to illness. He leaves behind his wife, Sandra B. Rightmeyer, with his step son, Johnathan E. Rightmeyer, all of San Antonio; two sons Jeffrey R. Riley, Michael A. Riley of Montgomery, TX; and brother Dr. David A. Riley of Morgantown, Virginia. Mr. Riley is a Master Mason, a retired member of the Texan and West Virginia Supreme Courts, and a Patriot member of the Sons of the American Revolution.
