



George Washington Keeling

December 24, 1914 - October 4, 2004

George “Tabor” W. Keeling born on December 24, 1914 in Crystal City, Texas passed away on October 4, 2004 at the age of 89. He worked for Phillips Petroleum Co. as an auditor and later as a service station owner/operator. Mr. Keeling was in the home building business in the 1950’s. In 1959 he traded a rental property acquired from the home building business for a fifty-six acre farm near Lytle, TX. This was the beginning of Keeling Grass Farm in Lytle, TX that he owned and managed until his retirement in 1997. He was a member of Woodland Baptist Church and the Texas Sod Producers Association. Mr. Keeling was preceded in death by his wife of 62 years, Janice Keeling in 1996.
