Jesse W. Uresti, Hispanic entrepreneur and founder of Uresti Camper Sales, passed away on Wednesday, April 26, 2006 at his home in San Antonio. He and his wife, Susie, created three successful businesses in Ft. Worth and San Antonio; The Tortilla Factory, Duncan Cafeteria and Uresti Camper Sales. Jesse remained active in business until his retirement in 1988. Jesse W. Uresti was born in San Antonio on February 10, 1928. He is survived by his beloved wife of 56 years, Susie G. Uresti. Also survivors include his children, Susan and husband William M. Tam, Camille and husband Eric C.
