Romanko Lee Blankinship was born on January 3, 1943 in Independence, Kansas. He passed away on April 22, 2010 at Christus Santa Rosa Hospital, San Antonio, Texas. Romanko served in the United States Air Force as an attorney and after retirement he was a substitute teacher for NSISD. He is preceded in death by his wife Sherry L. Blankinship and father Reno V. Blankinship. Survivors include his mother Freda L. Blankinship, children Patrick L. Blankinship and Brenda L. Gonzales and husband Jose Gonzales DDS, sister Renita Butler and brother Thomas A. 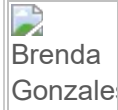

“ I am adding this remembrance of Romanko Blankenship in December 2021 on the occasion of my thinking of him today as i recalled my service in the US Air Force. We were colleagues at Luke AFB, Phoenix, AZ in the 1972-73-time frame. He was a Claims Officer in the Office of the Staff Judge Advocate (base legal office) and I was the Claims NCO -- a Staff Sergeant who had completed two years of legal education and was fulfilling my military obligation in the Vietnam Era with an Air Force enlistment. I appreciated his accepting me as a professional colleague recognizing that in the usual course I would have been able to complete my education and have been a JAG officer and not an NCO. Ironically, when I received orders from my prior assignment at Clark AB, Republic of the Philippines, I was destined for Forbes AFB in Topeka, KS and considered the possibility of completing my legal education at Washburn Law School while completing my Air Force active duty. But, those orders were changed and I was reassigned to Luke AFB. Currently, I am a retired lawyer, living in VT and part of a lunch group that includes a man from Topeka whose father was a law graduate of Washburn.

Our lives are lived in intersecting circles. I am glad that my life intersected with Romanko's at Luke AFB so many years ago. I am not surprised to read of his success in his Air Force legal career and teaching later. I am saddened that his life was cut short by cancer and send condolences to his children and grandchildren. May his memory be a blessing to all who were touched by his genuine kindness.
