William A. "Big Bill" Weilbacher went to be with the Lord after a long illness on January 27, 2005 at the age of 76. Big Bill was a Sergeant Detective from April 14, 1950 to September 1, 1977, with the San Antonio Police Dept. The Director of Security for Frost Brothers from 1978 to 1989, and he worked for the Bexar County Sheriffs Department from February 27, 1990 to February 28, 2001. He was a very loving and devoted Husband and Father. Big Bill is survived by his loving wife; Paula Weilbacher, four sons; Richard W. Weilbacher, J.V.
